

**THIRD ADDENDUM TO  
MEMORANDUM OF UNDERSTANDING**

This third addendum to the Memorandum of Understanding dated January 10, 2022, entered into the \_\_\_\_ day of \_\_\_\_\_, 2023, by and between TODD COUNTY BOARD OF EDUCATION (hereinafter called “District”) and the TODD COUNTY SHERIFF (hereinafter called “Sheriff”);

**WITNESSETH:**

Whereas, the District and the Sheriff entered into a Memorandum of Understanding dated January 10, 2022; and,

Whereas, the District and the Sheriff entered into a First Addendum to that Memorandum of Understanding dated the 12th day of September, 2022;

Whereas, the District and the Sheriff entered into a Second Addendum to that Memorandum of Understanding dated the \_\_\_\_ day of \_\_\_\_\_, 2023;

Whereas, it is the desire of the Sheriff and the District to memorialize the current total annual compensation of the school resource officers assigned to North Todd Elementary School, South Todd Elementary School, and Todd County Central High School, based upon the assignment of Rodney Mobely to North Todd Elementary School.

NOW, THEREFORE, it should be and is hereby agreed as follows:

1. Beginning September 1, 2023, through December 31, 2023, the Sheriff shall furnish three (3) school resource officers to the District whose school assignments shall be agreed upon by the District and the Sheriff.
2. For the period of September 1, 2023, through December 31, 2023, the compensation for the school resource officers shall be as follows:
  - a. Third Quarter 2023

Kendrick Harris	100%	\$11,684.40
Chris Driskill	100%	\$11,684.40
Rodney Moberly	75%	\$1,680.00

b. Fourth Quarter 2023

Kendrick Harris	100%	\$11,684.00
Chris Driskill	100%	\$11,684.00
Rodney Moberly	75%	\$7,200.00

3. The total compensation set forth in the Second Addendum to the Memorandum of Understanding is modified as set forth above beginning September 1, 2023.
4. In each and every other respect, the Memorandum of Understanding dated January 10, 2022, as modified by First Addendum, dated the September 12, 2022, and as modified by Second Addendum, dated \_\_\_\_\_, 2023, remains in full force and effect and its terms are incorporated herein by reference as except as modified herein.
