Recommendation/Motion: Approve the proposed additive Change Order No. Four to the contract with Rising Sun Developing for the construction of the New Mary E. Britton Middle School on Polo Club Boulevard, in the amount of \$5,635.00 (Five Thousand, Six Hundred Thirty-five Dollars) with an equivalent transfer of funds from Object Code 0840 to 0450; and a corresponding transfer of \$259.21 (Two Hundred Fifty-nine Dollars and Twenty-one Cents) for design consultant fees from Object Code 0840 to 0346.

Background/Rationale: The construction of the New Mary E. Britton Middle School on Polo Club Boulevard is listed as priority 1.a.3. on FCPS's 2017 (amended) District Facility Plan. JRA Architects produced final Construction Documents for bidding describing the new construction yielding a final project of approximately 171,983 SF to serve 1,200 students. Bids were received on July 28, 2022, and construction began in October 2022. The Office of Facility Design & Construction, the design consultants and the local building code officials have reviewed the progress of the work. Changes to the original plans and specifications have been necessary in order to satisfy the requirements described below. Approval of these changes allows the work to be completed. The description and cost of these items are summarized as follows:
