superintendent to sign same.


Rationale:

The Data Privacy Agreement details the type and limitations of shareable data, its appropriate use, and the responsibilities of each party. Data sharing will begin upon acceptance of this Agreement and will terminate when the services terminate. All procedures and processes will be FERPA compliant. Period, scope, and protections are also outlined in the attached Agreement. The Amendment to the ePrep CERT DPA is to add title NCLB/GAP and additional criteria on Exhibit B so data can be pulled and used

as MAP data has been previously in high schools.

AMENDMENT TO THE AGREEMENT BETWEEN EPREP, INC., AND JEFFERSON COUNTY BOARD OF EDUCATION

THIS AMENDMENT TO THE AGREEMENT BETWEEN EPREP, INC. AND JEFFERSON COUNTY BOARD OF EDUCATION (hereinafter "Amendment") is entered by and between the Jefferson County Board of Education, a political subdivision of the Commonwealth of Kentucky doing business as the Jefferson County Public Schools (hereinafter "JCPS") with its principal place of business located at 3332 Newburg Road, Louisville, Kentucky 40218, and ePrep, Inc. (hereinafter "Contractor") with its principal place of business located at 51 Colony Road, Readfield, ME 04355.

WHEREAS, The Parties have entered into a Data Privacy Agreement between JCPS and Contractor effective July 1, 2023 (the "Agreement"); and

WHEREAS, the Parties wish to amend the scope of services to add additional products;

THEREFORE, the Parties wish to amend the Agreement to alter Description of Services and Schedule of Data.

This Amendment hereby amends Exhibit A of the Agreement to add the following item to Description of Services: NCLB/GAP.

This Amendment hereby amends Exhibit B of the Agreement by adding the attached Exhibit B such that the Agreement shall have one Exhibit B consisting of 2 separate schedules of data, one for NCLB/GAP and the other for all other titles.

All other provisions of the Agreement shall remain unchanged. This Amendment is the entire agreement of the parties regarding modifications of the Agreement provided herein, supersedes all prior agreements and understandings regarding such subject matter, may be modified only by a writing executed by the parties. The Agreement is ratified and confirmed in full force and effect in accordance with its terms, as amended hereby. In the event of any conflict between the terms of the Agreement and this Amendment, the provisions of this Amendment shall control.

This Amendment may be executed via electronic signature in one of more counterparts, each of which will be deemed an original, but all such electronic signatures and counterparts will together constitute but one and the same instrument.
