3. Any time past the arranged drop-off time will be an additional charge in 30-minute increments for all reservations. Transfer/point trips are given a 15-minute grace period from the scheduled pick-up time, if client is not in the vehicle within

that 15-minute grace period the trip will change to an hourly reservation.
