Memorandum of Agreement Terms and Conditions Revised January 2023

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, KENTUCKY DEPARTMENT OF EDUCATION ("the Commonwealth") and FLOYD COUNTY BOARD OF EDUCATION("the Contractor") to establish an agreement to support students receiving special education services within career and technical education and, specifically, the area technology center structure. The initial MOA is effective from October 15, 2023 through September 30, 2024.

Scope of Services:

The Kentucky Department of Education (KDE) and Floyd County's ATC program (Floyd County Area Technology Center) will proactively address the needs of students with disabilities through collaboration with employers across the learning continuum, in-person and virtually. The request by Floyd County's ATC and Director of Special Education is to create and supervise a new role, Special Education/Career and Technical Education Outreach Coordinator. The coordinator will operate proactively to ensure that students with disabilities are included in ATC recruitment and enrollment, provided career awareness opportunities, facilitate transition assessment, and improve special education systems on behalf of students with disabilities. The coordinator position would be funded through the ARP grant and implemented through September 2024. This role aligns with KDE's interest in improving post school outcomes for students with disabilities.

Floyd County Public School District will hire a Career and Technical Special Education Outreach Coordinator to support students receiving special education services within career and technical education and, specifically, the area technology center structure. The coordinator will service students with disabilities at the ATC and support outreach efforts for feeder schools in Floyd and surrounding school districts. The Floyd County Director of Special Education and Floyd County ATC Principal will monitor, evaluate, and update the program while simultaneously acting as a liaison to stakeholders (grant personnel, district supervisors and feeding districts).

Goals and Deliverables:

Piloting a system to transform Floyd County School District's ATC program by proactively addressing the needs of students with disabilities, and collaborating with employers across the learning continuum, in-person and virtually. To develop, implement, and maintain a partnership among and between secondary and postsecondary institutions, businesses, and employers.

Outcomes expected upon the completion of this project:

- *Capacity building for instructional supports within the ATC environment.
- *Improved competitive, integrated, and paid employment opportunities for students with disabilities during and after high school.
- *Inclusion in the general education, career and technical curriculum.
- *More students with disabilities participating and completing CTE programs.
- *Improved community experiences for students with disabilities.
- *Promote universal design learning within the ATC learning environment.
- *Improved Indicator 14 employment outcomes.
- *Increased Graduation rate.
- *Decreased Dropout rate.

Program Structure and Personnel. Floyd School District shall:

- *Provide support and supervision of a newly created ATC Outreach Coordinator position, ensuring the following roles and responsibilities are maintained:
- *Provide necessary accommodations, modifications and specially designed instruction as dictated by the IEP to students at the ATC.
- *Provide specifically designed instructional support to faculty and staff
- *Develop in-person and virtual job shadowing opportunities to recruit and review career choices *Develop a student action plan to support individualized high quality academic core content and technical skills, which focus on a specific career cluster and prepare the

exceptional student to successfully transition toward their career goal and meet the goals of the student's individual learning plan.

- *Attend Admissions and Release Committee (ARC) meetings to review transition components, multi-course summary of studies, postsecondary goals, retain consent from parent to work with an in-district and out-of-district employee specialist and/or Office of Vocational Rehabilitation (OVR).
- *Communicate and collaborate with parents and students on success of pathway and IEP goals. Ensure that the student's interests, strengths, and needs are aligned with the CTE program.
- *Review the application process used for students without disabilities planning to enroll in the state approved CTE program. Ensure that students with disabilities follow the same process and receive support.
- *Establish a procedure for communicating with CTE staff after the student enrolls in the program. This will allow CTE staff to discuss progress toward the student's IEP goals, as well as to problem-solve collaboratively. It is important that specific and detailed information related to specially designed instruction and behavior support plans be communicated to CTE staff so that IEP goals can be accomplished.
- *Support a summer program.
- *Yearend program data reported.
- *District Supervisor of the Career and Technical Special Education Outreach Coordinator shall be the Floyd Independent Director of Special Education, maintaining the following responsibilities:
- *Monitor, evaluate and update the program.
- *Liaison to grant personnel and feeding districts
- *Develop a planning team
- *Continuously seek input from parents, students, and community stakeholders
- *ATC Building Supervisor of the Career and Technical Special Education Outreach Coordinator shall be the Floyd ATC Principal, maintaining the following responsibilities:
- *Monitor, evaluate and update program
- *Liaison to district supervisor and feeding districts

Interagency Collaboration. Floyd School District shall:

- *Convene quarterly a coordinating body, District Interagency Transition Team, that includes a student with an IEP, parent/guardian of a student with a disability, special educator, administrator, OVR counselor, and other relevant stakeholders.
- *Seek opportunities for engaging in cross-agency professional development.
- *Facilitate opportunities for outside agencies to conduct planning meetings with students and families.
- *Support and coordinate for the utilization of transition assessment data.
- *Collaborate program planning and development that includes employer involvement.

Student Development. Floyd School District shall ensure:

- *Coordinate student evaluations to identify student competencies, interests, relevant vocations (including kinds of work previously unconsidered) as well as learning about the impact of students' disabilities and related support needs.
- *Written vocational evaluation reports are completed and used to assist with the development of students' Individualized Plan for Employment through OVR (IPEs) and students' Individual Education Program (IEP) with the teacher.
- *Work with employers and students to develop personalized jobs.
- *Provides consultations for business personnel related to specific instruction and support needs of individual students—promoting instruction by those who typically provide training, and supplementing employer training as needed.
- *Provides follow-up services to promote job advancement and continuing success of students.
- *Maintain necessary records for the local school system and the Offices of Vocational Rehabilitation. Keeps current and complete information regarding each student in student notebook/file.
- *Purchase evidence-based in-person with teacher instruction/support and virtual instructional resources to enable students to gain skills needed to be career ready.

Independent Evaluation. Floyd School District shall:

- *Participate in an independent evaluation of the pilot program conducted by a third party identified by KDE.
- *Provide information and data to the independent evaluation team. An independent evaluation plan will be written to assess measures related to Floyd's final service delivery proposal. Examples of Paducah's data collection deliverables may include the following components: *CTE and Special Education teacher survey data.
- *Longitudinal data related to CTE Participation and completion for students with disabilities.
- *Longitudinal data related to career and academic readiness for students with disabilities.
 - *Assurance that students receiving special education services have the same access and opportunities to the course of study including CTE and work-based learning.
 - *Evidence of student participation collected quarterly (e.g., IC attendance and course enrollment data, Work-based learning agreements/reports)
- *Evidence of attendance and engagement.
- *Evidence of family/caregiver engagement.
- *Information related to a CTE special education teacher time study.
- *Information about professional development.
- *Student outcome information.

Student Focused Planning. Floyd School District shall ensure:

- *Student interests and preferences are documented.
- *Options are identified for postsecondary education and employment.
- *Educational program and multi-year course of study corresponds to postsecondary goal(s).
- *Provides transportation according to district's community-based instruction policies and procedures.
- *Students are prepared to actively participate in the IEP meeting.
- *Referral to adult service provider (i.e., OVR) occurs prior to student's exit from school in accordance with the IEP.

Family Engagement. Floyd School District shall ensure that:

Memorandum of Agreement Standard Terms and Conditions Revised January 2023

1.00 Effective Date

All Memorandum of Agreements are not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the agreement and until the agreement has been submitted to the government contract review committee. However, in accordance with KRS 45A.700, memoranda of agreement in aggregate amounts of \$50,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head, if the agency has been granted delegation authority by the Secretary.

2.00 EEO Requirements

The Equal Employment Opportunity Act of 1978 applies to All State government projects with an estimated value exceeding \$500,000. The contractor shall comply with all terms and conditions of the Act.

3.00 Cancellation Clause

Both parties shall have the right to terminate and cancel this contract at any time not to exceed thirty (30) days' written notice served on the Contractor by registered or certified mail.

4.00 Funding Out Provision

The state agency may terminate this agreement if funds are not appropriated to the contracting agency or are not otherwise available for the purpose of making payments without incurring any obligation for payment after the date of termination, regardless of the terms of the agreement. The state agency shall provide the Contractor thirty (30) calendar day's written notice of termination of the agreement due to lack of available funding.

5.00 Reduction in Contract Worker Hours

The Kentucky General Assembly may allow for a reduction in contract worker hours in conjunction with a budget balancing measure for some professional and non-professional

The Contractor also recognizes that any books, documents, papers, records, or other evidence, received during a financial audit or program review shall be subject to the Kentucky Open Records Act, KRS 61.870 to 61.884. Records and other prequalification information confidentially disclosed as part of the bid process shall not be deemed as directly pertinent to the agreement and shall be exempt from disclosure as provided in KRS 61.878(1)(c).

7.00 Violation of tax and employment laws

KRS 45A.485 requires the Contractor and all subcontractors performing work under the contract to reveal to the Commonwealth any final determination of a violation by the Contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to corporate and utility tax, sales and use tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively. Disclosure of any violations is required prior to the award of any state contract and throughout the duration the contract.

The Contractor agrees to provide, upon request, needed reasonable accommodations. The Contractor will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, religion, color, national origin, sex, sexual orientation, gender identity, age or disability. Such action shall include, but not be limited to the following; employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensations; and selection for training, including apprenticeship. The Contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this non-discrimination clause.

In all solicitations or advertisements for employees placed by or on behalf of the Contractor, the Contractor will, state that all qualified applicants will receive consideration
