## EAP ESTIMATES FOR TODD COUNTY SCHOOLS ELKTON, KENTUCKY

Companies contract with the Pennyroyal Center to provide confidential and professional assessment and counseling services to their employees. Through Employee Assistance Programs (EAP), employees can privately obtain help with health, legal, financial or family problems early. The Center's EAP provides the following basic services for one price:

SUPERVISORY TRAINING RE: EAP, MANDATORY REFERRALS, ETC.:

INTRODUCTORY PRESENTATION RE: EAP TO ALL PERSONNEL 4 sessions or more according to no. school sites.

BILLFOLD CARDS FOR EACH EMPLOYEE providing EAP information

MONTHLY POSTERS FOR EVERY POSTING SITE

OR EMPLOYEE SERVICES

SIX HOURS (6) OF RESEARCHED-BASED EDUCATION (PRIME FOR LIFE) on alcohol & drugs to employees/community

IMMEDIATE AVAILABILITY FOR CRISES MANAGEMENT, CONSULTATIONS

EMPLOYEE COUNSELING for screening & brief therapy.

REPORTS CONCERNING UTILIZATION & DEMOGRAPHICS ANNUALLY OR AS OFTEN AS REQUESTED.

Charges depend on the number of counseling sessions the school contracts and number of employees using EAP services annually. The basic cost for 350 employees and their families assuming a 5% utilization (17.5 employees &/or family members) the first year will range as follows:

- 2 visits \$2,800 OR \$8.00 per employee family annually
  - 3 visits \$3,850 OR \$11.00 per employee family annually
  - 4 visits \$4,900 OR \$14.00 per employee family annually
  - 5 visits \$5,775 OR \$16.50 per employee family annually
  - 6 visits \$6,125 OR \$17.50 per employee family annually

If 5 % more (10% of total employees) use services in a year, you will be notified and charges renegotiated the next year.

350 employees implies 875 potential covered lives.
