**Consent Agenda Item (Action Item):** Consider/Approve bid from Abbico Contracting regarding Preschool Classroom on Wheels

**Applicable State or Regulations:** BOE Policy 01.11, 04.32; KRS 45A.345-460

**Fiscal/Budgetary Impact:** ARP ESSER covers the cost of design and installation of inside and a full wrap of the outside to create a preschool classroom on wheels.

**History/Background:** Preschool opportunities are limited in Floyd County. Based on the Prichard Committee's Floyd County Profile, only 19% of three and four year olds in the county are enrolled in an education setting. The preschool classroom on wheels will be reaching and teaching 3 and 4 year olds who would not otherwise have access to a preschool education.

We will be taking the preschool classroom experience and putting it on a bus. The preschool classroom on wheels will be fitted with learning stations, educational toys, books, and other teaching and learning supplies. The activities will be aligned with Kentucky Early Childhood Standards and include story time, music, gross and fine motor activities, cooperative play, and exploration in the areas of reading, math, and science.

All expenses for interior and exterior of the classroom on wheels is covered through ESSER funding. The board approved advertisement for bids for custom design of outside and inside of preschool classroom on wheels bus during the August 28<sup>th</sup> regular board meeting. Bids received were open during the November 6<sup>th</sup> special called meeting. After reviewing and discussing all bids, the board requested Abbico Contracting present at the November 27<sup>th</sup> board meeting to be held at Betsy Layne Elementary. After this meeting the board requested an itemized breakdown of costs for next meeting.

**Recommended Action:** Approve bid by Abbico Contracting for Preschool Classroom on Wheels.
