Consider/Approve the acceptance of a donation from the Do Good Grant sponsored by the Joe Burrow Foundation to assist families who are struggling with food insecurity.

<u>APPLICABLE BOARD POLICY:</u> 01.011 General Power and Duties of the Board

HISTORY/BACKGROUND:

The Kenton County School District (KCSD) has had a 3.6% increase of students identified as economically disadvantaged and needing support with food donations. Currently, KCSD has 45.9% of the families who qualify to receive Free and Reduced Meals. The Do Good Grant sponsored by the Joe Burrow Foundation is donating money to the Kenton County School District. These funds are to expand the FRYSC resources that address the needs of KCSD families with food insecurities. The full donation amount will be deposited in a district account called "The Joe Burrow Foundation." FRYSC coordinators or the school's designee will identify when a family is in need of food support and will make a request to use the "The Joe Burrow Foundation" funds. The donation does not have a time table for using the funds as the funds can rollover to future school years.


