As requested by Deputy Barnett, attached you will find the Fourth Addendum to the Memorandum of Understanding between the Todd County Board of Education and the Todd County Sheriff regarding the provision of school resource officers. As you will note paragraph 2 sets forth the total annual compensation for the deputies assigned to each school. This amount is based upon the spreadsheet provided by Deputy Barnett. One item which the undersigned specifically noticed on the spreadsheet is Deputy Driskill's salary with benefits is listed as \$61,793.22 while Deputy Harris' salary with benefits is listed at \$71,308.42. It is also noted that Deputy Harris' hourly rate is listed at \$34.28 and Deputy Driskill's hourly rate is listed at \$29.71. Please verify those amounts are correct.

**FOURTH ADDENDUM TO
MEMORANDUM OF UNDERSTANDING**

This fourth addendum to the Memorandum of Understanding dated January 10, 2022, entered into the ____ day of _____, 2024, by and between TODD COUNTY BOARD OF EDUCATION (hereinafter called “District”) and the TODD COUNTY SHERIFF (hereinafter called “Sheriff”);

WITNESSETH:

Whereas, the District and the Sheriff entered into a Memorandum of Understanding dated January 10, 2022; and,

Whereas, the District and the Sheriff entered into a First Addendum to that Memorandum of Understanding dated the 12th day of September, 2022;

Whereas, the District and the Sheriff entered into a Second Addendum to that Memorandum of Understanding dated the ____ day of _____, 2023;

Whereas, the District and the Sheriff entered into a Third Addendum to that Memorandum of Understanding dated the ____ day of _____, 2023;

Whereas, it is the desire of the Sheriff and the District to extend the term of this agreement and to memorialize the current total annual compensation of the school resource officers assigned to North Todd Elementary School, South Todd Elementary School, and Todd County Central High School.

NOW, THEREFORE, it should be and is hereby agreed as follows:

1. The term of this agreement shall be extended commencing January 1, 2024, and concluding December 31, 2024.
2. The District shall reimburse the Sheriff annually for salary, benefits, and retirement as follows:

Chris Driskill	\$61,793.22
Kenrick Harris	\$71,308.42
Rodney Moberly	\$35,934.61

3. In each and every other respect, the Memorandum of Understanding dated January 10, 2022, as modified by First Addendum, dated the September 12, 2022, as modified by Second Addendum, dated _____, 2023, and as modified by Second Addendum, dated _____, 2023, remains in full force and effect and its terms are incorporated herein by reference as except as modified herein.
