### **MUNICIPAL ORDER 3-2024**

A MUNICIPAL ORDER DECLARING PROPERTY LOCATED AT HILLCREST GOLF COURSE AS SURPLUS PROPERTY AND AUTHORIZING THE MAYOR TO EXECUTE A DEED CONVEYING 0.764 ACRES, AND PERMANENT AND TEMPORARY EASEMENTS OVER ADDITIONAL TRACTS, TO THE COMMONWEALTH OF KENTUCKY, **FOR** THE USE AND **BENEFIT** OF TRANSPORTATION CABINET, FOR THE PURPOSE CONSTRUCTING AND MAINTAINING A ROUNDABOUT AT THE INTERSECTION OF OLD HARTFORD ROAD, FAIRVIEW DRIVE AND FOORS LANE.

WHEREAS, the City of Owensboro owns an undivided one-half (1/2) interest in certain real property located at 4346 Old Hartford Road which contains Hillcrest Golf Course; and

WHEREAS, the City now desires to declare a 0.764 acre portion of this property to be surplus property, so it can be sold to the Commonwealth of Kentucky, for the benefit of the Transportation Cabinet (hereafter "the Commonwealth"), for a roundabout to be constructed at the intersection of Old Hartford Road, Fairview Drive, and Foors Lane; and

WHEREAS, the City also desires to grant permanent and temporary easements to the Commonwealth over and across portions of the Hillcrest Golf Course property to allow for construction and maintenance of the roundabout; and

**WHEREAS**, conveyance of the property and easements will have substantial benefit to citizens of Owensboro in alleviating traffic at the intersection, and will have only a temporary minimal impact upon golfers at Hillcrest.

NOW, THEREFORE, BE IT ORDERED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

- **Section 1.** In accordance with KRS 82.083(3), the Board of Commissioners makes the following determination:
  - (1) The surplus real property owned by the City is located at 4346 Old Hartford Road.
  - (2) The intended use for the property at the time of its acquisition was a golf course.
  - (3) It is in the public interest to dispose of the property listed above so that it can be used to build a roundabout to alleviate traffic congestion at the intersection of Old Hartford Road, Fairview Drive, and Foors Lane.
  - (4) The property located at 4346 Old Hartford Road shall be conveyed for monetary consideration to the Commonwealth.
- **Section 2.** By and through the Board of Commissioners, a 0.764 acre portion of the property located at 4346 Old Hartford Road, as described on the attached Exhibit A, is hereby declared surplus property which may be transferred, sold, or otherwise conveyed in accordance with KRS 82.083.
- **Section 3.** That the City of Owensboro, Kentucky, by and through its Board of Commissioners, hereby approves the sale of the 0.764 acre portion of property located at 4346 Old Hartford Road to the Commonwealth.
- **Section 4.** That the City of Owensboro, Kentucky, by and through its Board of Commissioners, further approves the grant of permanent and temporary easements over portions of the property located at 4346 Old Hartford Road to the Commonwealth for construction and maintenance of the roundabout. The tracts over which the easements are granted are described on the attached Exhibit B.

**Section 5.** That the Mayor, City Manager and appropriate staff members are hereby authorized to sign the deed and all other documents deemed necessary to the furtherance of the authority outlined herein.
