





JUNE SCHOLASTIC EVENTS UPDATE

- Summer 2025 Proposal from NCAA for Boys Dates
 - Option 1 Two weekends in June that do not overlap with Father's Day or Juneteenth
 - Option 2 National Association of Basketball Coaches Proposed Six-Consecutive Day June Model
 - Split 2.5 days and 2.5 days to separate events
 - Option 3 One three-day weekend and one three-day week in June.
- No changes to Girls Dates
