Dear Mr. Danny Clemens, Director of Facilities,

We propose to render professional survey services in connection with the Topographic Survey – Bullitt Co. Schools – East – North - Central in Shepherdsville, KY (hereinafter called "the project"). This proposal represents a legal agreement between JQOL Inc., the designer of record and Bullitt Co Schools (Client). We will provide the Basic Services as described in Project Description below. Terms and Conditions shall be as provided in this proposal.

### **Project Description (Survey)**

- 1. Surveyor will prepare a Topographic / Utility Survey for the site including the following:
  - a. Establish horizontal control (KYTC Coordinates)
  - b. Establish vertical control (1988 Datum)
    - Set a minimum of 3 temporary benchmarks on each site to be used during construction
  - c. Select topographic survey (50-foot grid) and 10-foot overlap topographic survey
    - i. East Site (13.6 acres)
    - ii. North Site (30.6 acres)
    - iii. Central Site (15 acres)
    - Show spot elevations to the nearest 0.01 foot on hard surfaces and 0.10 foot on soft surfaces
    - v. Provide the location, size and elevation of all improvements within the survey limits
    - vi. Plot the location of storm drainage structures, sanitary structures, roads, driveways, edges of curbs, parking areas, walks, water's edge of ponds (if available), drainage ways, fencing, etc.
    - vii. Provide the location and size of individual trees inside and outside of wooded areas larger than 24" DBH within the survey limits

Kapur & Associates, Inc. is pleased to submit this proposal for professional survey services required for the Bullitt County Public Schools – Phase 2 Athletics and Field Houses project. Services include an updated site survey and Topographic Survey for Bullitt East, Central and North schools.

#### **BOUNDARY/TOPOGRAPHIC SURVEY**

The Boundary/Topographic Survey will include the following scope.

- 1. The Survey
  - a. Kapur will supply a Boundary, Site, and Topographic Survey for Bullitt East, North and Central school projects. Boundary standards for the State of KY will be met and applied to all verifications of the property boundary and with all adjoining parcels.
  - b. Permanent horizontal and vertical control will be set on site for future use. A minimum of 3 horizontal and vertical points will be set. Points shown on the site survey will be referenced to the KY North Coordinate System, NAD '83 (2011) or applicable site datum coordinate system.
  - c. Kapur will not reconcile discrepancies of ownership between neighboring properties. Kapur shall apply sound boundary law and the standards of practice in this area relative to any conflicts found between the field survey, the recorded legal description and how the neighboring properties impact our survey. Discrepancies will be noted on survey, if applicable.
  - d. Site topography will be collected for the creation of 1' contours. First floor elevations will NOT be shot at each building entrance on the subject property.
  - e. Above and below ground utilities will be located within the proposed improvements area. Below ground utilities will be field surveyed based on a private locator contractor's field marks. Manholes will be located, and depths will be measured provided that casting covers can be removed in the topographic area. Kapur will require any existing plans of the site or an on-site meeting with the owner that will aid in locating existing above and below ground utilities.
  - f. Kapur will locate and detail all visible site improvements within the proposed improvement boundary area, including but not limited to, buildings (major corners), grandstands, sidewalks, scoreboards, fences, athletic ground improvements, lighting, athletic fields, tracks and courts, parking lots, curb and gutters, drive entrances, pavement or hardscaping areas and above ground electrical and other utilities, transformers, switches, meters, valves.
  - g. Storm drainage features will be located, and depths will be measured provided that the casting covers are able to be removed. If dye testing is required to determine storm runs, it will be completed on a time and materials basis. The need for this is rare, however, there are occurrences where storm runs

are required for design and crews are not able to determine existing storm connections through visual observation.

- h. Wood lines or heavy brush lines will be shot as a tree line and not each individual tree or bush.
- 2. Kapur will contact a private utility locating contractor for utility markings. Existing plans, and local knowledge from the Owner is essential identifying existing private utilities. Private underground marking firms will require a known approximate location of private underground utilities and tone connection points to mark traceable utilities. Underground marking firms are not responsible for unknown and "un-locatable" non-metallic utilities. The fee for private underground marking will be billed at cost plus 10% in addition to the lump sum fee.
- 3. Mapping will be prepared with Civil 3D Release 2023. Layering conventions will be per Kapur layering standards. Kapur will supply a detailed spreadsheet of our layer naming conventions for the client to reference as a description of the layer content.
- 4. Kapur will collect ground elevations over the balance of the proposed survey area. Upon completion of data collection, a 1-foot interval contour map will be created with spot elevations.
- 5. A surface Digital Terrain Model (DTM) will be provided electronically to the client upon request.
- 6. Kapur has the resources to start the work immediately.
- 7. A Title Policy will be required for each parcel (This is to be provided by the owner) if not Kapur can order titles as needed at a cost to be determined later. The fees for the title policy (if ordered by Kapur) will be billed at cost plus 10% in addition to the lump sum fee.
- 8. Snow cover greater than ½" may delay field work until melt off. If client requires survey completed when snow conditions hamper normal survey operations, a request for additional services may be required.
- 9. All deliverables will be provided electronically as well as a wet sealed paper copy to the Client.
