RBS is not found of making any change to the sub-contractor list. Based upon the project manual, GN's letter requesting the change of sub-contractor and response to our questions, RBS has no objection to this change. There is always risk associated with administering a contract for the owner, architect and contractor. A low bidder requesting a change of sub-contractors is not typical but not uncommon. It does happen for many reason and considering the stated reason, our tendency is to approve.

The KDE version of the AIA front end, does not have any stated reasons on when or why a sub-contractor can be changed. If the owner has no objections then RBS would recommend to move forward with this change. However if the owner has reason to object, then RBS needs to know the reasoning before making a final recommendation.

Craig,

The local subcontractor being replaced, Knight Electric has voiced concerns to me on 2 fronts.

- 1. The new subcontractor (Don's Electric), is not reputable. Allegedly they are not licensed, cannot bond, and cannot issue a PO for lighting...
- 2. The General Contractor allegedly shopped the electrical work after bids were awarded. In Knight's opinion that is illegal.

I do not know the merit of these claims, or if it should pose any issue, but I do want to be transparent and forthright in disclosing what has been argued.

I am inclined to go along with the request to change subcontractors, but I don't want to open the district to litigation, nor do I want to sever any relationships that will make future projects difficult for the board.

Can you provide any additional insight? We can discuss further over the phone if you like.

Kyle, we offer the following response to these allegations below:

- 1,) Don's is a reputable Electrical Contractor having completed work on a recent RBS project for Hancock County School. I have confirmed with Mr. Cox (owner of Don's Electric) that Don's is a licensed and insured contractor. They are not required to provide a bond or issues P.O. to the owner on this project. The bond is required by GN Excavating. Material suppliers may require P.O.'s but this project does not.
- 2.) Most people including myself consider it unethical to shop a bid. To my knowledge shopping a bid is not a legal issue. RBS does it best to keep this from happening by requiring the bidder to list their sub-contractors on the form of proposal. In this case the bidder is claiming in writing that they made a mistake.

Kyle,

This will confirm our telephone conference this afternoon regarding the request of the general contractor, GN Excavating and Trucking Corp ("GN Excavating"), to change the listed sub-contractor from Knight's Electric to Don's Electric.

I reviewed the correspondence from GN Excavating to the architect, Craig Thomas of RBS Design Group, explaining the mistake made in its bid and the answers they provided to the questions raised by the architect. I also reviewed the General Conditions of the Contract for Construction that you forwarded to me.

Paragraph § 5.2.4 provides: "The Contractor shall not substitute a Subcontractor, person or entity previously selected if the Owner or Architect makes reasonable objection to such substitution."

The architect has asked if the Russellville Independent School District has any objection to the substitution. You advised that the architect has worked with the general contractor and subcontractor in the past and had no concerns regarding the qualifications of either. Based on the architect's experience, and the language in the General Conditions, I believe the District should not have any objection to the substitution and should not have any legal exposure to other bidders.

I note the correspondence indicates the general contractor may save \$100,000 by this substitution. Perhaps the District could negotiate some savings by this change.
