BACKGROUND INFORMATION:

The Board of Education is required to vote to approve the purchase of buses through the Kentucky State Contract Procedure.

SUMMARY OF MAJOR ELEMENTS:

The state recommends that districts purchase 6-7% of their fleet each year to maintain their fleet of buses. Our district would need to purchase 2-3 buses a year to maintain this percentage. This year the district needs to purchase two 84 passenger buses (the largest possible to support the new high school and trips) and one special needs bus (to replace our oldest special needs bus still in service on a daily route). The RFP was submitted through the state and the board is required to approve the purchase of buses through this process. The new buses will be number 2501, 2502, and 2503. The total cost of the three buses will be around \$576,000 from the General Transportation Fund.
