

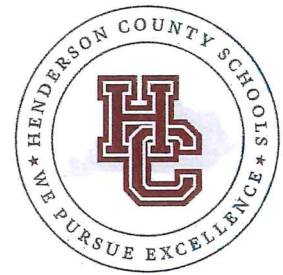

Office Supplies Bid #1-21-5-2

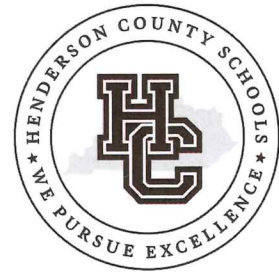
