Dear Mr. Perry,

Thank you for allowing Weatherproofing Technologies, Inc. ("WTI") to provide you with a proposal for installing wall panels and copings. Please see the detailed scope of work below.

SCOPE OF WORK:

Option 1 - Wall Panels

- 1. Set up necessary safety equipment needed to perform job safely per OSHA specs.
- 2. Install three hat channels along wall where panels will be installed,
- 3. Install flush panels the length of the wall, (80lf).
- 4. Install Z channel at top and J channel at bottom to enclose new panels.
- 5. Remove all materials and debris from the roof and dispose of in customer supplied container.

Quote to Perform Above Scope: \$19,090.00

Option 2 - Coping

- 1. Install wood nailers on 326 linear feet of parapet wall on the auditorium.
- 2. Install a continuous cleat on the outside of all coping.
- 3. Install a vapor barrier over the cleat and wood nailers.
- 4. Install 24 gauge metal coping with the cleat outside and over wall and attached to the inside of the wood nailers with topside fasteners.
- 5. Remove all materials and debris from the roof and grounds.

Time & Material Not To Exceed: \$39,070.00






Concrete coping joints are failing






Concrete coping is cracking throughout

All of these defects are causing significant water damage to the concrete coping and inside of the building. A metal coping system will permanently eliminate the water intrusion and maintenance issue with having to re-caulk these joints periodically.
