The Agreement may be terminated without liability for any one or more of such reasons by written notice from one party to another. If such event materially affects at least 21% or more attendees' travel to or attendance at the event, but, Group determines that it wants to proceed with the event, the Hotel shall waive any room, food service, beverage service, or other guaranteed minimum requirements stipulated in the Agreement and no liquidated damages will be due from the Group.</p> <p>A cancellation may be accepted without penalty up to 24 hours in advance of arrival.
