#### Overall increase in drug/alcohol offenses in OCS

- 2013 2014; 48 drug/alcohol offenses
- 2022 2023; 111 drug/alcohol offenses Increase of 131.25%

## Change to synthetics/artificially modified (mostly include THC, K2, Kush, Delta 8, Delta 9)

- 2013 2014; 20.83% of offenses involved synthetics
- 2022 2023; 79.37% of offenses involved synthetics

#### 2nd time offenders within single school year

- 2013 2015; average 2 repeat offenders per year
- 2021 2023; average 14 repeat offenders per year

### School-based Programming

- Partnership with Health Department to educate on effects of vaping
- Programs for parent groups on vaping, security, etc.



June 2023: The Renaissance program was updated to respond to increase in offenses, as well as increase in same-year repeat offenders. Changes below:

- Increase from 1 day at BAHS to 9 days
- New drug education curriculum for students to work through during 9 day stay
  - Truth about Drugs
  - Truth about Marijuana
  - Truth about Alcohol
  - Narcan Impacts and Studies
- Partnership with PEACE Hospital to conduct chemical dependency assessment for each student. PEACE collaborates with student's parent/guardian to make a recommendation regarding therapy and treatment

2021-2022: 16 same-year repeat offenders 2022-2023: 12 same-year repeat offenders 2023-2024: 0 same-year repeat offenders (as of 2/19/24)
