ORDINANCE 6-2024

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO CERTAIN **UNINCORPORATED** TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF CITY. BEING PROPERTY ADJACENT TO 2710 WEST PARRISH AVENUE (TRACT I) CONTAINING 0.089 ACRES, MORE OR LESS. AND PROPERTY LOCATED ADJACENT TO PARRISH AVENUE (TRACT II) 2808 WEST CONTAINING 0.913 ACRES, MORE OR LESS, AT THE REQUEST OF THE COMMONWEALTH OF KENTUCKY, DEPARTMENT OF HIGHWAYS.

WHEREAS, the Board of Commissioners for the City of Owensboro, Kentucky, makes the following findings of fact:

- (1) The Board of Commissioners has determined that the property described hereinafter is adjacent or contiguous to the city's boundaries.
- (2) That the property described hereinafter, by reason of population density, commercial, industrial, institutional, or governmental use of land, or subdivision of land, is urban in character or suitable for development for urban purposes without unreasonable delay.
- (3) The Commonwealth of Kentucky, Department of Highways, made a request for annexation of its property, the property is contiguous to the existing city

- (4) boundary, and the City has provided written notice to Daviess County Fiscal Court at least forty-five (45) days prior to the enactment of this ordinance.
- (5) That it is deemed desirable and it is hereby proposed to annex to the City of Owensboro by extending the boundary line of the city so as to include within the same, that certain territory which is now embraced within the County of Daviess adjoining the present boundary line of the City of Owensboro, as more particularly described herein.
- (6) The Board further finds that no part of the area to be annexed is presently within the boundary of any other incorporated city.
- (7) That the fee simple owner of record of the territory to be annexed, has previously consented in writing to the annexation proposed, and has otherwise waived all rights under KRS 81A.412, 81A.420 and 81A.425, which consent and waiver is on file with the office of the City Engineer.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

Section 1. The findings of fact recited in the preamble hereinabove are hereby adopted, affirmed and incorporated by reference as if fully set forth herein.

Section 2. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, Commonwealth of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

TRACT I: 0.089 ACRES

Proposed annexation for Carter Road (Hwy 2698) right-of-way, Tract I containing 0.089 Acres located on the west side of Owensboro, Daviess County, Kentucky more particularly described as follows:

Beginning at a point in the intersection of the south right-of-way line of West Parrish Avenue (Hwy 81) and the west right-of-way line of Carter Road (Hwy 2698), said point having a Kentucky State Plane South Zone Coordinate N:2161923.46, E:1236875.25 and being in the Current City Limit Line; thence following the old right-of-way line of Carter Road (Hwy 2698) and the Current City Limit Line as follows: N 79°22'30" E, 16.28 feet to a point; thence S 64°07'49" E. 24.80 feet to a point: thence S 22°48'01" E. 38.80 feet to a point: S 01°42'32" E, 246.83 feet to a point; thence S 01°20'23" E, 87.68 feet to a point; thence following the Current City Limit Line S 77°50'19" W, 9.49 feet to a point in the new west right-of-way line of Carter Road (Hwy 2698), said point being in the Current City Limit Line; thence following the new west right-ofway line of Carter Road (Hwy 2698) and the Current City Limit Line N 01°43'24" W, 87.58 feet to a point; thence leaving the Current City Limit Line and following the New City Limit Line and the new west right-of-way line of Carter Road (Hwy 2698) as follows: N 01°43'24" W, 257.72 feet to a point; thence N 35°56'21" W, 30.23 feet to a point; thence N 67°48'36" W, 27.39 feet to the point of beginning containing 0.089 Acres as shown on an annexation plat prepared by the City of Owensboro dated 12/14/2023.

Section 4. Any approved dedicated streets, alleys, or easements on the plat signed by the City Engineer, constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.

Summary & Background:

Commonwealth of Kentucky, Department of Highways, District Two, owner of said right of way has returned a signed consent letter to the City of Owensboro as consent to this annexation.

The proposed annexations for right of way are in the 1500 to 1800 Block of Carter Road (HWY 2698) Tract I being adjacent to 2710 W. Parrish Avenue being 0.089 acres and Tract II being adjacent to 2808 W. Parrish Avenue being 0.913 acres and are both zoned B-4.

This right of way annexation is requested in conjunction with a previous annexation of property at 2808 W. Parrish Avenue, the City of Owensboro will annex portions of Commonwealth of Kentucky right of way along Carter Road (HWY 2698) to improve municipal connectivity and continuity.


Dear Mr. Collignon:


