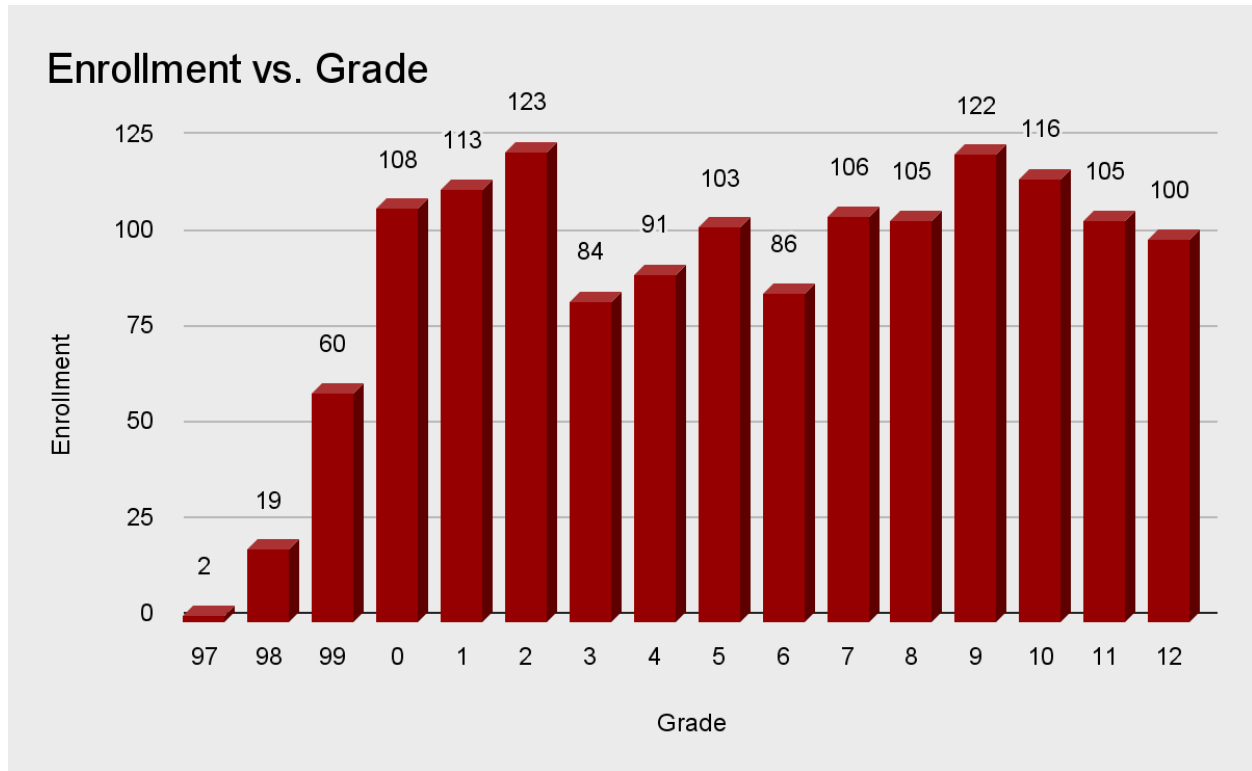


**Newport Independent Schools**

**Enrollment**

Enrollment at Newport Independent Schools on February 27, 2024 is 1443, an increase of fifteen students over prior month. Newport School of Innovation has its highest enrollment with 70 students.

**Federal Programs**

**Title I, Part A**

The Kentucky Department of Education has purchased Title I Next, a PCG Group software product for school district use beginning in FY 25. All school principals, assistant principals, and Federal Program staff had the opportunity to participate in virtual training during February. This product houses documentation outlined within Title I and assurances that Newport Independent maintains through a shared drive. Private Schools will not have access to Title I

## Newport Independent Schools Pupil Personnel, Student Services, & Federal Programs

Next and our Federal Programs staff will continue to monitor and house private school documentation.

Each district in Northern Kentucky is preparing the Declaration of Participation for private and homeschools for the 2024-2025 school year. Private schools must return the completed Declaration by the deadline to participate and receive funding for those attending students with a residence in Newport, Ky.

Principals are currently reviewing student and staffing needs for the 2024-2025 academic year as part of their needs assessment for federal programming. Each school is making progress with their school schedules.

### Enrollment Comparison

As a portion of a data health check, the DPP office ran academic performance and enrollment comparison data for two grades, 6th and 11th. The purpose of the data health check was to monitor the academic success of students continuously enrolled through Newport Independent as compared to students who have transitioned to Newport Independent. Grade levels were chosen based on the transition stage. Kentucky Summative Assessment is the measurement tool utilized to measure academic success. Students were separated into three groups: K-6th continuous enrollment, PK-6th continuous enrollment, and transferred students. Student identity was protected by removal of identifying information and assignment on random integers. Group size was set at 10. Raw data was shared with community member Lynn Schaber, representative of an Education Task Force within Newport, Ky. Findings are comparative.
