These speakers share their experiences and proven strategies to help educators succeed in the classroom and in their careers.

Facilities:

Building Update: As our organization continues to grow, we are finding it more difficult to host larger groups at NKCES as our space is limited. The parking lot is definitely an area of concern.

As part of the Arts In Mind project, an outdoor arts and professional learning center will be installed to meet the needs of learners. The center will be located outside in the space between the modulars and the Synergy Room exterior wall. Work has been ongoing, weather permitting, on the stage and surrounding outdoor space. We are expecting to complete it in the coming months.

Professional Learning (PL) Update:

February Professional Learning: NKCES supported 138 professional learning opportunities focused on academics, culture and climate, leadership, and special education during January, serving 1,489 educators.

Professional Learning (PL) Consortium: The 23.24 NKCES PL Consortium continued in February with a collaborative meeting. Topics included <u>NKCES IDEA/SERTAC Update</u>, <u>NKCES Learning &</u> <u>Empowerment Update</u>, and monthly district share-out. The meeting ended with a member-led PLC discussion.

Title I & Title II Meeting: The 23.24 NKCES Title I/Title II Consortium continued in February with a collaborative meeting. Topics included <u>Title II Coordinator Responsibilities</u>, <u>Title I Coordinators</u> <u>Responsibilities</u>, Discussion of Declaration Dates for Spring 2024, (Data pull from Diocese (Feb 2), <u>Diocesean Confidentiality Agreement</u>, Mail to Non-public Schools (Mar 1), Due date for documentation returned to districts (Mar 15), and deadline for paperwork submission to KDE TBD), <u>FY25 Declaration of Participation Forms</u>. District Assessment Coordinator (DAC) Meeting: The 23.24 NKCES DAC Consortium continued in February with a collaborative meeting. Topics included ACT, AKSA, EOP, and KSA (DAC Training, <u>TAM/Scripts</u>). The meeting ended with a member-led PLC discussion.

Special Education Update:

Ms. Brittney Howell, Regional Director of Special Education, addressed Emergency Certification Teacher emails from KDE. As most are aware, KDE issued emails to all Directors of Special Education and teachers holding current certifications that are on an "emergency basis" in the areas of LBD, MSD, and IECE. These emails contained information regarding the federal law requirement of states not issuing emergency certificates for any Special Education Certification (LBD, MSD, ICEC) starting in the 2024-2025 school year. Brittney has worked with Misti Carr to provide DoSEs guidance on moving forward. <u>Alternative Certification Routes</u>

Mrs. Amanda Bell and Jacki Alexander worked with Blair Hicks to provide University of Florida's Literacy Institute (UFLI) training. The work of UFLI focuses on two main areas: teacher development and reader development. The place where those two overlap is where the work of UFLI lives. This training provided resources and implementation guidance to help teachers become more confident and more successful in their capacity to help kids learn to read.

The NKCES SERTAC team completed Services Feedback summary to District Administration in Walton Verona. We are so thankful to Walton Verona Middle School for welcoming us in to see the great things that are happening in their special education program. Ms. Brittney Howell met with district administration to be able to review the data the SERTAC team collected and developed action for future professional learning and celebration.

Mrs. Jacki Alexander held the February Transition Cohort training. The NKTI training on Person Centered Planning was amazing. We had roughly 30 participants engaged in deep conversation regarding student participation and ownership in the planning of their future. Teachers walked away with multiple resources and tools to assist with student engagement and planning. Key websites such as Life Course Nexus, NTACT, and I'm Determined were explored for additional resources and support.

Learning and Empowerment Team:

Northern Kentucky Institute for Arts Education (NKIAE)

In February, Mr. Joe Bertucci provided information and resources for Cohort 3 of the Arts In Mind program, serving 30 schools in 17 districts. These schools will be developing Comprehensive Arts Plans in March. Videos for Season 3 of our *Arts Express* series, supporting instruction in elementary dance, were filmed. In addition, Mr. Bertucci attended two national conferences to support our work in the region:



The Kennedy Center's *Partners in Education* Annual Meeting (with Boone County Schools) and The U.S. Department of Education's *Assistance for Arts Education* Project Directors' Convening. He also led training for a professional learning cadre in Ft. Thomas Independent Schools.

Northern Kentucky Institute for Strategic Prevention (NKISP):

The NKISP team held their Steering Committee Meeting this month. They attended several coalition meetings with various community partners. The team worked on visiting schools for the Youth Advisory Board.

School-Based Mental Health (SBMH) and Trauma Informed Services in Schools (TISS):

The SBMH & TISS grant work has been focused on assisting districts with the implementation of grant activities along with providing additional guidance to clarify financial processes. Most of the recent work included meeting with individual districts to assist with providing additional information regarding grant financial processes, planning future mental health professional learning opportunities, collaborating with SPF Grant staff to plan & implement the Youth Advisory Board Pilot Project with four high schools in our region, assisting with planning the upcoming Student Mental Health Roundtables, participating in professional learning opportunities to gain knowledge for grant activities, implementing a virtual meeting to provide additional grant support for District Finance Directors, and collaborating to implement the first customized Sprout Box for teachers to get professional learning resources focused on personal wellness.

Deeper Learning: The Deeper Learning team continues to collaborate with various stakeholders for the 2024 Deeper Learning Summit for the June 10 and June 11 event. The DL team concluded the UK Next Gen cohort with continued work with 6 districts on Portrait of a Learner. The Deeper Learning Phase II data collection and DL Sustainability Plan was submitted to KDE on February 28, 2024.

CRRSA Team: CRRSA team served 17 districts to include Northern Kentucky University, reaching over 250 educators with PL opportunities to include topics on UFLI, MTSS, Tier 1 Lesson Planning, etc. The NKCES CRRSA team continued working with CRRSA teams across the state on the Social Emotional Learning and Learning Acceleration task groups which are projected to be shared this summer. The CRRSA SEL Specialists worked with students across seven districts that are participating in the upcoming NKY Student Mental Health Roundtable Event.
