The Hopkins County Board of Education would like to request a School Emergency Day Waiver for Tuesday, March 5, 2024 for West Broadway Elementary School due to a fire that occurred in the school library after school on Monday, March 4, 2024. Allowing students and staff to attend school on Tuesday, March 5, 2024 would have been a health and safety risk as the Madisonville Fire Department advised school and district officials that the air quality in the building remained insufficient for occupancy for 24-36 hours after the fire was extinguished.
