Recommendation/Motion: Approve the initial BG-1 Project Application for the construction of the New Henry Clay High School in the amount of \$151,610,227.60 (One Hundred Fifty-one Million, Six Hundred Ten Thousand, Two Hundred Twenty-seven Dollars and Sixty Cents.)

Background/Rationale: The construction of the New Henry Clay High School is listed as priority 1b.3, 5.21, and 5.22 on FCPS's 2021 District Facility Plan (DFP) amendment #2. The design team has started planning new construction, yielding a final project of approximately 322,569 SF to serve 2,300 students. The program is consistent with other recent FCPS school projects and the KDE model program. Initial project cost estimates are based on the most recent FCPS construction bids and include estimated design and financing fees; furnishings; technology; surveys; and other miscellaneous project costs. The project has already started with programming. This will be phased construction to start in 2025 and final completion in winter 2028. Tate Hill Jacobs Architects was approved as the design consultant for this project at the Board's September 11, 2023 meeting.
