

**RINEYVILLE ELEMENTARY SCHOOL-BASED

January 29, 2024**

The Rineyville Elementary School-Based Decision Making Council met on January 29, 2024. Ms. Breeding called the meeting to order at 3:17 p.m.

I. OPENING BUSINESS

A. RECOGNITION OF VISITORS

B. AGENDA APPROVAL

The agenda was reviewed and approved by A. Musselman and seconded by M. Young, motion carried

II. DECEMBER MINUTES

The minutes from December were reviewed and A. Musselman motioned to approve, seconded by M. Dorsett. All members were in favor, motion carried

III. COMMITTEE MEETING MINUTES

A. M. Young presented minutes from the Instructional Committee. At their last meeting they discussed their concern with math scores and not seeing the growth they were wanting. They discussed using more manipulatives. S. Breeding is going to each room to talk about brain growth.

Ms. Alford and Bree Cunningham made up a schedule using the special area teachers during times when they don't have a class to go in and assist in the 1st grade. S. Breeding will be going into every class to talk about brain growth.

STAFFING



- E. M. Dorsett and K. Arnette said there was nothing from parents that they had heard about


XII. ADJOURNMENT
