DEED OF CONVEYANCE

THIS DEED, made and entered into this ______ day of _______, 2024 by and between POWELL COUNTY BOARD OF EDUCATION, by and through SARAH WASSON, in her official capacity as Superintendent of the Powell County Board of Education, 691 Breckenridge Street, Stanton, Kentucky 40380, Grantor, in whose care the state and county tax bill for the aforesaid calendar year may be sent, and the COMMONWEALTH OF KENTUCKY, for the use and benefit of the TRANSPORTATION CABINET, DEPARTMENT OF HIGHWAYS, Frankfort, Kentucky 40622, Grantee;

WITNESSETH:

NOW THEREFORE, for and in consideration of TWENTY-ONE THOUSAND, SIX-HUNDRED DOLLARS

(\$21,600.00) cash in hand paid, the receipt of which is hereby acknowledged, the Grantor has bargained and sold and does hereby sell, grant and convey to the Grantee, its successors and assigns forever, in fee simple with covenants of General Warranty, the following described property and property rights located in Powell County, Kentucky:

Parcel 10

Tract A

Being a tract of land lying in Powell County along Halls Lane approximately 269 feet northwest of the intersection of KY-11/KY-15 and Halls Lane, and more particularly described as follows:

It is the specific intention of the grantor herein to convey a permanent easement to the property description above for the purpose of constructing and perpetually maintaining drainage.

It is the specific intention of the grantor herein to convey a permanent easement to the property described above for the purpose of the Grantor agreeing not to erect buildings, structures, or other objects, permanent or temporary, or modify the land use that increases loading on the surface of this easement. Grantor further agrees not to construct or place, longitudinally along or otherwise within the Permanent Easement any tree, underground pipeline, cable, wire, conduit, value, stub, storm water drainage pipeline facilities or other utility or appurtenance. Any existing buildings, structures, or other objects currently within the easement area will be allowed to remain undisturbed.

Tract C

The above-described parcel contains 0.514 acres (22376.456 sq. ft.)

It is the specific intention of the grantor herein to convey a temporary easement to the property described above for the purpose of slope construction; said easement terminates and reverts upon completion of same.

The above-described property is being acquired by the Grantee pursuant to a public highway improvement identified as construction of a right turn lane on Halls Lane (KY 207) at the Powell County High School, Item No. 10-9019.00, Project No 1100 FD04 099 1317901R. The acquisition of the right-of-way for this project was authorized by Transportation Cabinet Official Order No. 113008. The control of access on this project

shall be by permit, as required to be set forth in Section 6 of the Kentucky Administrative Regulations (603 KAR 5:120).

Being a portion of the property conveyed to the Grantor, Powell County Board of Education, by deed from James H. Hall, et al., dated August 26, 1969 of record in Deed Book No.

59, Page No. 336 in the office of the Powell County Court Clerk.

Together with all improvements and fixtures situated thereon and all rights and privileges thereto. The Grantor further covenants that it is lawfully seized of the property hereby conveyed, with full right and power to convey same, and said property is free of all encumbrances except restrictions and easements of record and all real estate taxes due and payable in 2024, which said Grantor hereby promises and agrees to pay in the event it's not exempt from same.

TO HAVE AND TO HOLD said property and property rights unto the Grantee, its successors and assigns, with all the rights and privileges thereunto belonging with covenants of General Warranty.
