
The Area E exterior CMU walls that will be exposed at the end of Phase 1 are to be sprayed with foam insulation. As shown on the wall sections on the Phase 1 drawing A-343, the exterior walls at Vocal Classroom E106, Custodial Receiving E105 and the Kitchen on the First Level will be covered with brick, metal panels, and a CMU wall in Phase 2. A portion of wall that will be an interior wall at the north entry vestibule on the First Level in Phase 2 also needs to be covered with spray foam insulation in Phase 1. That vestibule wall and the spray foam insulation will be covered with another CMU wall in Phase 2.

Break out the cost to cover the spray foam insulation with a fire and weather resistant coating. Submit product information on the proposed coating.
