- 14 Section 1. Definitions.
- 15 (1) "Classified employee" means the same as in KRS 161.011.
- 16 (2) "Paraprofessional" means a classified employee, regardless of school district-assigned job
- title, who performs instructional support duties which may include:
- 18 (a) providing one-on-one tutoring if such tutoring is scheduled at a time when a student would
- 19 not otherwise receive instruction from a teacher;
- 20 (b) assisting with classroom management;

- 1 (c) providing instructional assistance in a computer laboratory;
- 2 (d) providing instructional support in a library or media center;
- 3 (e) acting as a translator; or
- 4 (f) providing instructional support services under the direct supervision of a teacher.
- 5 Section 2. Minimum qualifications for a paraprofessional.
- 6 (1) To qualify for a position as a paraprofessional in the common schools, an individual shall
- 7 possess knowledge of basic subjects taught in the common schools, including arithmetic,
- 8 grammar, spelling, language, and reading.
- 9 (2) Possession of the knowledge required in subsection one (1) of this section shall be
- demonstrated by the successful completion of a high school diploma or a high school
- 11 equivalency diploma.
- Section 3. Minimum qualifications for paraprofessionals in Title I schools.
- 13 (1) To qualify for a position as a paraprofessional in a school that receives funding under Title I
- of the Elementary and Secondary Education Act of 1965, or its successor, an individual shall
- meet the requirements of Section 2 of this regulation, and shall possess:
- 16 (a) two years of study at an institution of higher education;
- 17 (b) an associate's degree; or
- 18 (c) a passing score on the state assessment required by Section 5 of this regulation.
- 19 (2) Paraprofessionals who only serve as translators or who only conduct parental involvement
- 20 activities are exempt from the requirements of this section.
- 21 Section 4. Local education agency flexibility.
- 22 (1) Local education agencies may add required qualifications in addition to those set forth in this
- 23 regulation for paraprofessional roles.

- 1 (2) Local education agencies shall adopt and implement policies to ensure that any classified
- 2 employee that meets the definition of a paraprofessional in Section One of this regulation meets
- 3 the minimum qualification requirements of this regulation regardless of locally created job titles.
- 4 Section 5. Criteria for the statewide paraprofessional assessment.
- 5 (1) The Kentucky Department of Education shall make available a standardized paraprofessional
- 6 assessment that evaluates an individual's knowledge of:
- 7 (a) Correct oral and written usage of English;
- 8 (b) Child guidance principles and practices;
- 9 (c) Classroom procedures and conduct;
- 10 (d) Basic instructional techniques;
- 11 (e) School and classroom rules, policies and procedures;
- 12 (f) Safe practices in classroom activities;
- 13 (g) Reading and writing communication skills;
- 14 (h) Interpersonal skills using tact, patience and courtesy; and
- 15 (i) Record-keeping techniques.
