HISTORY/BACKGROUND:

Pursuant to KRS 157.655-157.660 and 750 KAR 2:010, the School Facilities Construction Commission has made an official KY-2024 KETS Offer of Assistance. Acceptance of this Offer of Assistance commits the District to follow the statutes and regulations of the SFCC and the Kentucky Department of Education governing the Education Technology Funding Program. Based upon statewide ADA figures, the Second Offer of Assistance in FY-2024 is in the amount of \$112,272. Acceptance of the state technology fund Offers of Assistance must be matched equally by the District or can be escrowed for up to (3) years.

FISCAL/BUDGETARY IMPACT:

Acceptance of the Offer of Assistance will be equally matched by the District in the amount of \$112,272.
