Consider / Approve the bid award with Riegler Blacktop for the River Ridge site expansion project (BG #24-173) and corresponding contract pending board attorney approval of the contract.

APPLICABLE BOARD POLICY:

HISTORY/BACKGROUND:

The Board previously approved the initial BG-1 (24-173) and schematic design for the River Ridge site expansion project on December 4, 2023. Sealed bids for this project were received and opened on Thursday, March 14, 2024. Members of the Operations team evaluated the three bids received from Alpha Construction, Riegler Blacktop, and Schrudde and Zimmerman using the bidder scoring matrix from section "001153 - Qualification of Bid Proposal" document included in the American Institute of Architects (AIA) bid documents provided to all bidders. After a review of bid amounts, firm experience and qualifications, business practice, and references, the Operations team selected Riegler Blacktop as the recommended contractor to complete the project, to include accepting bid alternates 1, 2, 3, and 4 in addition to the base bid.

\$3,783,500 base bid and bid alternates

On Thursday, March 14, 2024, the three following base bids were received for the River Ridge Site Expansion project:

Alpha Construction	\$3,373,749.00
Riegler Blacktop, Inc.	\$3,589,000.00
Schrudde & Zimmerman, Inc.	\$3,860,000.00

We also received alternate bids for the following items:

Alternate No. 1: Replace the existing loading dock.

Alternate No. 2: New headwall, storm line extension, and fence reconfiguration.

Alternate No. 3: Water service replacement along Radio Road.

Alternate No. 4: Additional sidewalk and curb replacement, and additional underdrain at the pick-up / drop-off loop.

The attached Bid Tabulation dated March14, 2024 lists the prices received for the alternates listed above from all Bidders.

District staff convened in the days following the bid to conduct the bid qualification procedures as outlined in Section 001153 "Qualification of Bid Proposal" of the bid specifications. The resulting ranking of the Bidders based upon District staff's investigations and interviews with the Bidders' references resulted in Riegler Blacktop, Inc. having the Best and Lowest Bid. The table below lists their alternate bid values.
