Due to a variety of issues with our current college and career readiness/college admission platform, we will not be renewing with Naviance which is owned by PowerSchool. Over the last several months, Dr. Barger and I have spent an extensive amount of time reviewing the SchoolLinks platform. In addition, we have had the SchoolLinks representative present to a variety of staff who are involved in supporting students in the college and career readiness world. Based on feedback from middle school and high school counselors and CCR coaches, SchoolLinks provides our district with what we need related to meeting ILP requirements, connecting to the Common App for admissions, and supports students in learning about their interests and passions for future careers. This is an early access agreement only running until the end of June 2024 which provides us on-site training, virtual training, and one time implementation fees for all the components. A new year long contract for the platform and curriculum will start July 1, 2024 which will be requested for approval at a later time. The cost will be \$22,123.23 and will be funded through Title IV, BEAM, and the curriculum, assessment, and instruction department funding. Approval is requested for the renewal of the Naviance platform for a 6-month period of time.
