- The newly created demographic boundaries will be delivered to BCS in the form of a new database in Routefinder Plus. This will provide the district with a data source that will be representative of the district's 2024-2025 student demographics.
- A fresh import of student enrollment data for the 2025-2026 school year will need to be brought into the
  database at BCS. BCS may then need to adjust the school boundaries to accommodate changes in student
  enrollment.

### **Key Assumptions**

This agreement is based on the following assumptions:

- BCS staff will provide historical student data (preferably 5 years of past enrollment data and corresponding boundaries from the past)
- BCS will provide walk-to-school and walk-to-stop parameters.
- BCS will provide other data pertinent to boundary planning.
- Students will be assigned to schools based on their home address with any exceptions in assignments provided by BCS.
- Frequently upon review of the Demographics Study, a revision may be requested to consider slight variations on the boundary options provided. TPS will provide one revision as part of this agreement. Should additional revisions be needed, TPS will be happy to provide further options at the cost of \$2,000/day (most revisions take a day to provide updates).

#### Summary

Bullitt County Schools (BCS) has requested Transfinder Professional Services (TPS) provide demographic services to develop new school boundaries in the Routefinder Plus system. BCS currently has 22 schools and is hoping to better balance the number of students across their school buildings.

#### **Project Scope**

This SOW is preliminary and will be further defined as Transfinder's Professional Services (TPS) team works with Bullitt County Schools (BCS) resources and staff. The following are the preliminary activities and deliverables.

- A comprehensive project plan outlining the work to be done by both BCS and TPS will be developed upon receipt of this signed statement of work. This project plan will include deadlines for work to be completed. Both parties understand that missing dates on any assigned tasks will cause the dates for all subsequent tasks to be delayed.
- Transfinder will access BCS's Routefinder Plus data for BCS in the Transfinder Hosted Network (THN). This will enable TPS and BCS to collaborate on the demographic project.
- Transfinder will collect and analyze demographic data from the following sources to prepare a report for BCS:
  - o Any county planning and/or zoning departments identified by the district
  - Any regional demographic analysis currently utilized by the district for demographic planning
  - BCS will be asked for historical student data and accompanying school boundaries (preferably 5 years of past enrollment data and corresponding boundaries)
  - Transfinder will provide a written report to Bullitt County Schools detailing the methodology and results of analyzing the school district's boundary structure.
- Transfinder's standard demographics report contains the following elements:
  - Executive Summary An overview of the project objectives and parameters
  - Methodology An explanation of the methodology used to compile the report
  - Demographic expectations by area based on known growth
  - Demographic expectations compared to capacity by school
  - Historical Enrollment and patterns
- Using the data collected in the areas above, multiple scenarios (typically 3) will be provided with suggested boundary configurations to act as potential starting points.
