- Ground freight shipping included.

- Set of electronic submittals, including a bill of materials, product data sheets and installation shop drawings.

- Job site meeting with contractor prior to installation, to review system design and answer any installation questions.

- The services of a qualified field technician to start-up the system and train personnel in its proper operation and maintenance are included. When the installation is nearing completion, please fill-out the commissioning form, found in the front of the submittal, and send it back to the Vincent Lighting project manager allowing at least three weeks lead time to schedule our field technician.

- End user training to consist of an initial four hour session, at a time mutually agreed upon between owner and VLS.

- All Lifts, Ladders, or equipment required to access Vincent Supplied equipment are to be provided by the Electrical Contractor or End User.

- Final termination of low voltage control, wiring which has been supplied, installed, and tagged by the electrical contractor at equipment listed in this Bill of Materials. VLS Terminations to exclude houselight fixtures on the field side and any Fiber Optic cabling.

- All items will be warranted to be free from defects in materials and workmanship for a period of 24 months from the date of system turn-on and owner's acceptance. This warranty is exclusive of normal wear and tear. Vincent Lighting is not responsible for the cost of the removal, shipment to Vincent Lighting for repair, or re-installation of returned serviced or replacement warranty equipment.

- For possible warranty repair returns, we recommend you retain some manufacturers shipment cartons for

TERMS & CONDITIONS

All shipments are FOB factory, ground freight allowed to the jobsite. Freight claims must be filed directly with the shipper. Any product shortages must be reported to the Vincent Lighting project manager within 72 hours from time of delivery. Any claims thereafter will not be honored.

Unless evidence of tax exempt status is provided, Vincent Lighting Systems may charge sales tax for items shipped to destinations in the following states: Arkansas, Colorado, Indiana, Kentucky, Michigan, North Carolina, Ohio, Pennsylvania, Vermont, Virginia, and West Virginia. For orders shipped to other states, you are solely responsible to report & pay for all taxes, including use tax if applicable, to the Department of Revenue of your state. You can contact your respective taxing authority for detailed information.

This order will be purchased in accordance with our Bill of Materials and quotation. Receipt of your purchase order for the agreed amount signifies acceptance of the quoted terms. There shall be no modification to terms without written acceptance by Vincent Lighting Systems.

The Bill of Materials and pricing are based on our interpretation of the drawings, plans and specifications received in this office and represent a system using components that fulfill the design intent of the project. Orders placed for the above referenced project shall be "as per Vincent Lighting Bill of Materials".

Payment terms are net 30 days on approved accounts. A service charge of 2% per month will be applied to all invoices not paid within 30 days. If you wish to open an account, please fill out the enclosed credit application. If you do not intend to pay sales tax, please furnish us with a signed tax-exempt certificate. Return the forms to Shelley Hammond, Credit Manager, by fax at (216) 475-6376 or email at shammond@vls.com.

It is Vincent Lighting Systems' policy to request a copy of the Notice of Commencement filed with the County Recorder, if required by the state within the project is located. If applicable, Vincent Lighting Systems will serve a Notice of Furnishing to the Owner and Prime Contractor at the appropriate time. The actual requests will be mailed separately via certified mail.

The equipment will be ordered on a hold for release basis. Submittal drawings for approval will take approximately 6-8 weeks. Manufacturing time will be approximately 30 to 90 days after approval and written release. Release for manufacture and shipment of all equipment is required within 120 calendar days after receipt of order. It is Vincent Lighting Systems' policy that orders not properly released within this period are subject to a 2% per month increase. Orders placed and subsequently canceled where either as-built or submittal drawings have been started or the purchase of special materials is required, will be assessed a cancellation charge of 25% of the quoted price for the order or actual costs incurred, whichever is greater.
