#### **MUNICIPAL ORDER 8-2024**

A MUNICIPAL ORDER AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE A REAL ESTATE PURCHASE AGREEMENT FOR THE ACQUISITION OF PROPERTY LOCATED AT 3001 WEST 2ND STREET, 35 CARTER ROAD AND 45 CARTER ROAD.

**WHEREAS**, Audubon Loans, Inc. owns certain real property located at 3001 West 2<sup>nd</sup> Street, 35 Carter Road and 45 Carter Road in Daviess County, Kentucky; and

WHEREAS, the property owner now desires to sell the real property located at 3001 West 2<sup>nd</sup> Street, 35 Carter Road and 45 Carter Road in Daviess County, Kentucky; and

**WHEREAS,** the City of Owensboro seeks to acquire said property as the location for a new senior center.

NOW, THEREFORE, BE IT ORDERED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

**Section 1.** The Board of Commissioners hereby authorizes and directs the Mayor and other appropriate city officials to execute a real estate purchase agreement which sets forth the terms and conditions for the City's acquisition of the property located at 3001 West 2<sup>nd</sup> Street, 35 Carter Road and 45 Carter Road. The property is more particularly described on Exhibit A.

**Section 2.** That the City of Owensboro, Kentucky, by and through its Board of Commissioners, hereby approves the purchase of 3001 West 2<sup>nd</sup> Street, 35 Carter Road and 45 Carter Road, in accordance with the terms of the proposed real estate purchase agreement mentioned above in Section 1, as such purchase is for the purpose of serving as the location for a new senior center.

**Section 3** That the Mayor, City Manager and appropriate staff members are hereby authorized to sign any and all deeds or other documents deemed necessary to the furtherance of the authority outlined herein.
