- Must have a signed permission trip/ medical form on file.

Academics

- Students must have displayed appropriate academic effort in all classes prior to the date of the trip.

Attendance

Beginning Monday, April 15th, 2024 through May 24th,

- Students cannot have more than
 - 1 unexcused tardy (to school)
 - 1 unexcused absence

Behavior

Beginning April 15th, 2024 through May 24th,

- Students cannot:
 - Have **ANY major** behavior infractions including, fighting, possession or use of a vape or other tobacco products, destruction of property, threats, aggression, etc.
 - Be suspended from school
 - Be enrolled at Powell County Academy

Suggested Packing Checklist:
