Bullitt County Fiscal Court has recently acquired the West Bullitt Recreational property behind Nichols Elementary. They plan to turn the property into a park that can be used by the Nichols school community. They are requesting the removal of fences, debris and buildings that are not salvageable around the old baseball field. The baseball field is partially on BCPS property. Also permission is required to use and upgrade the former baseball field parking lot. This newly paved area will be available for use by park visitors and school activities. The Bullitt County Fiscal Court will pay for all materials and labor. The Bullitt County Road Department will maintain the park.

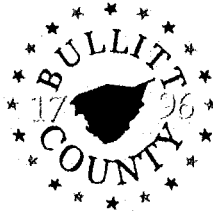
