THIS RESOLUTION BY THE OHIO COUNTY FISCAL COURT AUTHORIZING AN APPLICATION BY THE OHIO COUNTY FISCAL COURT AND/OR PADUCAH & LOUISVILLE RAILWAY, INC. TO THE UNITED STATES DEPARTMENT OF TRANSPORTATION FOR RAIL INFRASTRUCTURE PROJECT

WHEREAS, the Ohio County Fiscal Court ("Ohio County") plans to apply for the Multimodal Project Discretionary Grant Opportunity (MPDG) from the United States Department of Transportation as the lead applicant and otherwise for the benefit of the co-applicant, Paducah & Louisville Railway, Inc. ("PAL"); and

WHEREAS, Ohio County's application specifically seeks funding from either the Nationally Significant Multimodal Freight and Highways Projects Grants program ("INFRA") or the Rural Surface Transportation Grant program ("Rural") through its application, and desires to submit an application for the same; and

WHEREAS, Ohio County will use the funds for a rail infrastructure project that includes track and signal upgrades; installation of a wheel truing machine; and rehabilitation of five bridges, four located in Muhlenberg County, Kentucky, and the other in Hardin County, Kentucky. All rail infrastructure is located on the rail line of its co-applicant, Paducah & Louisville Railway, Inc. (the "Project").

WHEREAS, PAL shall be solely responsible for providing the matching funds necessary for the construction and completion of the Project should the grant funds be awarded; and

WHEREAS, PAL will provide funding for on-going operations and maintenance of these critical transportation improvements and enhancements should the grant funds be awarded;

NOW, THEREFORE, BE IT RESOLVED BY THE OHIO COUNTY FISCAL COURT AS FOLLOWS:

The Ohio County Fiscal Court ("Ohio County") supports the filing of a Multimodal Project Discretionary Grant Opportunity (MPDG) application for funding to be used for the upgrade of rail and signals, the installation of a wheel truing machine, and rehabilitation of five bridges, all of which are on the rail line of the co-applicant, PAL; and

Ohio County relies on PAL's representations that it has available matching funds to fulfill its sole obligation related to this grant application should the grant funds be awarded, and as such, Ohio County need not set aside reserves for the Nationally Significant Multimodal Freight and Highways Projects grants program ("INFRA") or the Rural Surface Transportation Grant program ("Rural") Match; and

That the officers of Ohio County be, and hereby are authorized to review and execute the application and any and all ancillary documents necessary to effectuate the filing of the grant application with the United States Department of Transportation.
