

## AMENDMENT TO THE DATA PRIVACY AGREEMENT BETWEEN SCENARIO LEARNING, LLC AND JEFFERSON COUNTY BOARD OF EDUCATION

THIS AMENDMENT TO THE DATA PRIVACY AGREEMENT BETWEEN SCENARIO LEARNING, LLC AND JEFFERSON COUNTY BOARD OF EDUCATION (hereinafter "Amendment") is entered by and between the Jefferson County Board of Education, a political subdivision of the Commonwealth of Kentucky doing business as the Jefferson County Public Schools (hereinafter "JCPS") with its principal place of business located at 3332 Newburg Road, Louisville, Kentucky 40218, and Scenario Learning, LLC (hereinafter "Provider") with its principal place of business located at 4890 W. Kennedy Blvd. Ste 300, Tampa, Fl 33609.

WHEREAS, The Parties have entered into a Data Privacy Agreement between JCPS and Contractor effective April 26, 2023 (the "Agreement"); and

WHEREAS, the product pricing for the 24/25 FY have been agreed upon and the original funding source has changed;

THEREFORE, the parties wish to amend the compensation section to account for current pricing and funding sources.

This Amendment hereby amends THE Exhibit A: to add Compensation paragraph of: for Fiscal year 24-25, Funds for purchase shall come from account code CM11053-0349-900XV. Total payments under this DPA shall not exceed \$99,956.88 from July 1, 2024 – June 30, 2025.

All other provisions of the Agreement shall remain unchanged. This Amendment is the entire agreement of the parties regarding modifications of the Agreement provided herein, supersedes all prior agreements and understandings regarding such subject matter, may be modified only by a writing executed by the parties. The Agreement is ratified and confirmed in full force and effect in accordance with its terms, as amended hereby. In the event of any conflict between the terms of the Agreement and this Amendment, the provisions of this Amendment shall control.

This Amendment may be executed via electronic signature in one of more counterparts, each of which will be deemed an original, but all such electronic signatures and counterparts will together constitute but one and the same instrument.
