# **RE: Ridge Cap and Closure Replacement**

Dear, Mr. Hawkins.

Thank you for allowing Tremco/Weatherproofing Technologies, Inc. ("WTI") to provide you with a proposal to replace the ridge cap and closures on the metal roof system at New Highland Elementary School.

## Metal Ridge Cap and Closure Replacement:

- 1. All Work to be completed according to OSHA guidelines for safety.
- 2. Remove and dispose of existing ridge cap, closures, and associated flashings in a contractor furnished trash receptacle.
- 3. Clean and prep existing metal panel to be free of all debris, caulking, and adhesive.
- 4. Existing metal roof panels to be tonged up at panel ends underneath ridge cap.
- 5. Furnish and install new precut foam closures between each panel rib on both sides of the ridge.
- 6. New closure to sealed along the back side of the foam to panel joint with new Commercial grade urethane sealant.
- 7. Fabricate and install new 24ga. Kynar 500 pre-painted ridge cap. New ridge cap to be shop formed and mechanically fastened to existing rib battens.
- 8. New Ridge cap to be slightly larger than existing to cover existing screw holes through rib battens. Old screw holes to be seal with Commercial grade urethane sealant prior to new ridge cap installation.
- 9. New ridge cap seams to have a minimum 2" overlap with a double beaded application of Commercial grade urethane sealant. All ridge cap seams to be pop riveted every 2" O.C. and pop rivet heads to be covered in a tooled application of Commercial grade urethane sealant.
- 10. Fabricate and install new 24ga. Kynar 500 pre-painted ridge end caps. End caps to be custom made to fit the profile of the installed angle of new Ridge cap.
- 11. Maintain an orderly jobsite and thoroughly clean upon completion.
