## INTERLOCAL AGREEMENT BY AND BETWEEN BULLITT COUNTY FISCAL COURT AND THE BULLITT COUNTY BOARD OF EDUCATION, KENTUCKY

INTERLOCAL COOPERATION AGREEMENT BY AND BETWEEN THE FISCAL COURT OF BULLITT COUNTY, KENTUCKY AND THE BULLITT COUNTY BOARD OF EDUCATION, KENTUCKY, PURSUANT TO THE INTERLOCAL COOPERATION ACT, KRS 65.210, ET SEQ., FOR THE PURPOSE OF ROAD MAINTENANCE AND IMPROVEMENT

WHEREAS, the Fiscal Court of Bullitt County, Kentucky (the "County"), and the Board of Education of Bullitt County, Kentucky (the "Board of Education"), desire to enter an Interlocal Cooperation Agreement (the "Agreement"), pursuant to KRS 65,210, et seq., for the purpose of construction, reconstruction or maintenance of a municipal road or bridge.

NOW THEREFORE, BE IT RESOLVED by the Fiscal Court of Bullitt County, Kentucky and the Board of Education of Bullitt County, Kentucky as follows:

- 1. This Agreement shall be effective upon May 7, 2024, and shall terminate on October 31, 2024;
- 2. This Agreement shall be administered by the Bullitt County Judge/Executive or his/her designee in coordination with the Superintendent of the Board of Education of Bullitt County, or his/her designee;
- 3. This Agreement is formed for the purpose of construction, reconstruction or maintenance of a municipal road(s) or bridge(s) and is limited to road work at Bebanon Junction Elementary School.
- 4. This Agreement shall be financed as follows: The County shall provide all equipment and labor to perform the road work and the Board of Education shall pay the cost of all materials therewith. The County shall certify, upon request of the Board of Education, that all material costs are properly secured from bids administered through the Kentucky Model Procurement Code. Billing for all materials shall be directly to and paid for by the Board of Education upon presentation of proper documentation as required by the Director of Finance of the Board of Education;
- 5. Notwithstanding the termination date set forth herein, this Agreement may be terminated at any time by a proper vote of the Fiscal Court or the Board of Education if deemed in the public interest to do so;
- 6. In the event of early termination of this Agreement, any and all property acquired pursuant to this Agreement shall be disposed of by the County in accordance with applicable law, and any funds resulting from such disposal shall be divided and distributed evenly between the County and the Board of Education;

- 7. The Parties shall indemnify, defend and hold harmless each other and their officers, employees, and agents from any and all suits, actions or claims of any character due to any injury or damage arising from the performance of work pursuant to this Agreement to the extent allowed by Kentucky law; and
- 8. A certified copy of this Agreement shall be filed with the Kentucky Secretary of State as required by KRS 65.290.
