

1. Agreement made 3-25-24 between More Than Entertainment (herein referred to as MTE) and Lindsey Gilpin (herein referred to as purchaser.)

2. Engagement Date: 04/27/24  
Engagement Time: 8pm-11pm  
Engagement Location: The Seelbach Grand Ballroom

3. Job Description or purchaser's requirements: DJ services for Prom (MTE or representative will use his/her best efforts to conform to rules and policies of the establishment).

4. MTE/Independent Contractor: More Than Entertainment shall at all times have complete supervision, direction and control over the services of the personnel on this engagement. MTE executes this agreement as an Independent Contractor, not as an employee of the Purchaser.

5. Contract Price: \$950 purchaser to return a nonrefundable booking fee of \$250 payable to More Than Entertainment with signed contract. Purchaser to pay balance to MTE or representative during first half of engagement.

6. Overtime: Purchaser must advise MTE or representative of overtime request within the last hour of the function. If MTE or representative agrees to overtime, the rate will be as follows: \$250/hr

8. Cancellation: Purchaser may cancel 60 days prior to event with written notice and must have written consent from MTE. Cancellation results in loss of deposit.


10. Purchaser shall furnish the following: a table 6 feet or longer with table cloth, a chair, electricity no further than 20 feet from the set up location, and a meal if one is provided to guests

Arbitration or Controversies: Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration in accordance with the Rules of the American Arbitration Association, or through civil court, under the laws of the State of Kentucky, in the State of Kentucky.

12. Indemnification: Purchaser and Artist recognize that MTE is acting as an agent for Artist. Purchaser and Artist hereby agree to indemnify and hold MTE harmless from and against any and all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments, and penalties arising out of, relating to, or associated with, or occasioned by the Event.

Contract must be returned within 10 days or agency reserves the right to cancel.
