#### Memorandum of Agreement Template

Revised October 2023

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, Kentucky Department of Education ("the Commonwealth") and Jefferson County Board of Education ("the Contractor") to establish an agreement for an Educational Recovery Leader position. The initial MOA is effective from July 1, 2024 through June 30, 2025.

#### Scope of Services:

To provide support to schools designated as Comprehensive Support and Improvement (CSI) through serving on audit teams, assistance with school turnaround plans and with implementation of turnaround plans and other required activities in KRS 160.346. Educational Recovery staff provide intensive support to leadership and teachers at low-performing schools.

#### Job Description:

The Educational Recovery Leaders (ERL) will serve in Comprehensive Support and Improvement (CSI) and/or provide support to Targeted Support and Improvement (TSI) schools to assist and support staff in the following areas while focusing on leadership, math and literacy in order to:

Assist school staff in utilizing needs assessment mechanisms such as the Key Core Work Processes to determine the "as is" state of the school according to priority areas.

Guide school leaders and teams in creating systems and structures to address the identified deficits highlighted by the Key Core Work Processes and eventually the improvement priorities, where applicable.

Assist leadership in ensuring curriculum is systematically aligned/revised to state and local standards through a continuous improvement process involving professional learning community structures.

Assist school leadership in ensuring the curriculum is implemented in all classrooms.

Work with staff to ensure the creation of a system of school-wide and classroom assessments that are rigorous and authentic are utilized to inform and improve instruction to meet the needs of all students.

Assist in creating systematic opportunities for school leaders and staff to collect and analyze relevant data that inform decision-making and development of response to intervention (RtI) practices.

Assist teachers in developing and implementing effective and varied, evidence-based instructional strategies to be used in all classrooms.

Provide resources and activities that will ensure the school functions as an effective learning community to support and promote a safe and orderly environment that encourages learning (e.g., Positive Behavioral Interventions and Supports [PBIS], Multi-Tiered System of Support [MTSS]).

Assist staff in working with families and community groups to remove barriers to learning.

Seek and provide appropriate, job-embedded professional learning opportunities for teachers and administrators based on school-wide needs assessment and identified individual and group areas for growth to enhance teaching and learning.

Assist with embedding processes for continuous improvement and systems within the school culture so that they guide the work of all staff in decision-making around teaching and learning.

Assist in organizing the school's linkage and systems to include all available resources, fiscal and human, to ensure maximum effectiveness and build capacity in school staff and teams on the use of processes and tools for improvement.

Any suit, action or other proceeding regarding the execution, validity, interpretation, construction, or performance of this agreement shall be filed in the Franklin Circuit Court of the Commonwealth of Kentucky.

Requirements for Reporting to Kentucky Teachers Retirement System:

Please note that, if contractor is a current retiree of the Kentucky Teachers Retirement System (KTRS), or proposes to use a current or potential retiree of KTRS to perform any work under any contract, this may have an adverse impact upon retirement benefits for that retiree. This would occur, regardless of whether a contract is awarded to the individual directly, or to another legal entity for which the individual works.

The Kentucky Department of Education reserves the right to withhold or cease funding for non-performance, or breach, during the life of the contract, if it is in the best interest of the Commonwealth to do so.

the purpose of financial audit or program review. The Contractor also recognizes that any books, documents, papers, records, or other evidence, received during a financial audit or program review shall be subject to the Kentucky Open Records Act, KRS 61.870 to 61.884. Records and other prequalification information confidentially disclosed as part of the bid process shall not be deemed as directly pertinent to the agreement and shall be exempt from disclosure as provided in KRS 61.878(1)(c).

#### 7.00 Violation of tax and employment laws

KRS 45A.485 requires the Contractor and all subcontractors performing work under the contract to reveal to the Commonwealth any final determination of a violation by the Contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to corporate and utility tax, sales and use tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively. Disclosure of any violations is required prior to the award of any state contract and throughout the duration the contract.

Contractor further affirms that it will (1) communicate the above KRS 45A.485 disclosure requirements to any subcontractors and (2) disclose any subcontractor violations it becomes aware of to the Commonwealth.

#### 8.00 Discrimination

This section applies only to agreements disbursing federal funds, in whole or part, when the terms for receiving those funds mandate its inclusion. During the performance of this agreement, the Contractor agrees as follows:
