**AMENDMENT TO THE AGREEMENT BETWEEN EVOLVE502  
AND JEFFERSON COUNTY BOARD OF EDUCATION**

THIS AMENDMENT TO THE AGREEMENT BETWEEN EVOLVE502 AND JEFFERSON COUNTY BOARD OF EDUCATION (hereinafter "Amendment") is entered by and between the Jefferson County Board of Education, a political subdivision of the Commonwealth of Kentucky doing business as the Jefferson County Public Schools (hereinafter "JCPS") with its principal place of business located at 3332 Newburg Road, Louisville, Kentucky 40218, and Evolve502 (hereinafter "Provider") with its principal place of business located at 334 E. Broadway, Louisville, Ky. 40202

WHEREAS, The Parties have entered into a Memorandum of Agreement between JCPS and Contractor effective May 8, 2024 (the "Agreement"); and

WHEREAS the Parties wish to clarify their commitments under the agreement

THEREFORE, the Parties wish to amend paragraph 1 of the agreement

This Amendment hereby amends paragraph 1 of the agreement to add the following.

x. Ensure that Community Learning Hubs/Backpack League sites have single access entry points that provide direct access to student areas and these entry points are locked and secured at all times, including but not limited to, front and rear doors, so that members of the community are not able to directly access students during Backpack League/Summer Learning/the Project.

y. Ensure that Community Learning Hubs/Backpack League sites that provide housing to members of the community have obtained background checks for tenants to ensure that violent and/or sex offenders are not in proximity to students during Backpack League/Summer Learning/the Project.

All other provisions of the Agreement shall remain unchanged. This Amendment is the entire agreement of the parties regarding modifications of the Agreement provided herein, supersedes all prior agreements and understandings regarding such subject matter, may be modified only by a writing executed by the parties. The Agreement is ratified and confirmed in full force and effect in accordance with its terms, as amended hereby. In the event of any conflict between the terms of the Agreement and this Amendment, the provisions of this Amendment shall control.

This Amendment may be executed via electronic signature in one of more counterparts, each of which will be deemed an original, but all such electronic signatures and counterparts will together constitute but one and the same instrument.
