MUNICIPAL ORDER 17-2024

A MUNICIPAL ORDER AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AN APPLICATION FOR THE FY2024 PAUL COVERDELL FORENSIC SCIENCE IMPROVEMENT GRANTS PROGRAM THROUGH THE BUREAU OF JUSTICE ASSISTANCE IN THE AMOUNT OF \$5,488.37, THE PROCEEDS OF WHICH WILL BE UTILIZED BY THE CITY OF OWENSBORO POLICE DEPARTMENT TO PURCHASE AN ULTRA LITE ALTERNATE LIGHT SOURCE; NO MATCH REQUIRED FROM THE CITY.

WHEREAS, Owensboro Police Department (OPD) operates a full-service latent print laboratory as part of the Evidence Collection Unit; and

WHEREAS, OPD has four (4) evidence technicians who each have advanced training in collecting and processing latent print evidence; and

WHEREAS, two (2) of the evidence technicians are board certified latent fingerprint examiners and they possess the training and expertise to utilize the requested equipment. In 2023, OPD latent print examiners worked 559 latent print cases resulting in multiple latent prints being identified in 124 of them; and

WHEREAS, the OPD requests to purchase an Ultra Lite Alternate Light Source to assist in the development of latent fingerprints and volatile substances in criminal investigations; and

WHEREAS, the Ultra Lite Alternate Light Source will allow evidence technicians to examine a crime scene quickly and thoroughly; and

WHEREAS, the OPD requests grant funds through the FY2024 Paul Coverdell Forensic Science Improvement Grants Program through the Bureau of Justice

Assistance in the amount of \$5,488.37, the proceeds of which will be utilized by the City of Owensboro Police Department to purchase an Ultra Lite Alternate Light Source; no match is required from the City.
