SURPLUS PROPERTY - DISPOSITION BY EASEMENT

On April 15, 2024, KDE received an email from Shane Smith, the district's chief operations officer / chief financial officer, informing us of a proposed easement to be granted to Kentucky Utilities (KU) for underground electric service at the new Woodford County High School campus. Per Mr. Smith's email, KU expects to receive the easement for no cost.

In support of this disposition by easement, the district provided the following:

• Kentucky Utilities Company - Terms and Conditions. Customer Responsibilities, dated July 20, 2021

Contingent approval is hereby granted by the district to start the disposition process. For final approval, the following information shall be submitted to this office:

REQUIRED DOCUMENTS FOR KDE REVIEW (Refer to the attached instructions for the submittal process)

- 1. Local Board's Assurance that disposal will not affect the integrity or usefulness of property crucial to the educational needs of the district.
- 2. **Proposed Easement Agreement** reviewed by the local district's board attorney. The proposed agreement shall include the following:
 - a. The parties to the agreement.
 - b. A legal description of the easement.
 - c. Documentation of receipt of fair market value.
 - i. If the easement benefits the school district only, the utility will not need to pay for the easement.
 - d. A reversionary clause that reverts the property back to the exclusive unrestricted control of the local board of education when the need for the easement no longer exists.
 - e. A plat by a licensed surveyor indicating the easement boundaries, acreage, and its relationship to the larger property.

On November 28, 2023, KDE received an email from Shane Smith, the district's chief operations officer / chief financial officer, informing us of a proposed easement to be granted to Columbia Gas for an underground gas line at the new Woodford County High School campus.

Mr. Smith's email included a copy of a proposed Right-of-Way (Easement) Agreement between the Woodford County School District Finance Corporation and Columbia Gas of Kentucky, Inc. for the consideration of \$1.00.

On April 16, 2024, in support of this disposition by easement, the district provided the following:

- Updated proposed Right-of-Way (Easement) Agreement between the Woodford County School District Finance Corporation and Columbia Gas of Kentucky, Inc. for the consideration of \$3,650.00.
- Appraisal by William L. Berley (Kentucky Certified General Appraiser #721) with Bluegrass Valuation Group, LLC indicating a fair market value opinion of \$3,650.00. The appraisal included the following:
 - Un-signed and un-dated plat of the easement by Columbia Gas of Kentucky indicated the selected portion of the property where the easement is to be located.
 - o Site Plan Sheet UM2.0 by Ross Tarrant Architects.

The plat and the site plan are not consistent with one another.
