History/Background:

Each student organization came up with a list of possible fundraisers with their lead teacher. The proposed fundraisers will assist in covering yearly regional, state, and national student organization fees; as well as, improve the instructional opportunities for students. These funds will cover expenses for students to compete in competitions for all organizations by funding the purchase of region, state, and national competition kits, supplies for competition builds and/or presentations, and subscriptions/equipment students may need to compete in the events. The funds will also help cover bus expenses for field trips for industry experience and travel to region, state, and national competitions. Since FCSI doesn't have a student account, funds generated by these fundraisers also cover food expenses for students during field trips, organization competitions, STLP, and senior banquet. The regional, state, and national student organization competitions encourage school banners and table cloths; therefore, funds generated by fundraisers will be used to purchase those as well. All fundraisers generate funds used to purchase senior banquet items (cords, pins, letters, and supplies/food), STEM nights (open house events), student competition shirts/polo/attire, and Phoenix Expo supplies, awards, etc. (robotics competition we began hosting last year). FCSI funds are used to purchase items that Title I and/Perkins funds will not pay for.
