Recommendation/Motion: Approve the recommendation from the Local Planning Committee (LPC) to amend (#3) the current 2021 District Facility Plan (DFP) per the Amendment Process described in Section 502 of 702 KAR 4:180, The School Facilities Planning Manual, and for the Board to establish a date, time, and location for the Public Hearing in regard to this amended DFP. Amended items include the following, which the Board requested on February 12, 2024: (1) building improvements for school-wide communication systems, class audio, school safety, (2) air purification systems, (3) removing renovation items 4.3 (Joe G White Maintenance Bldg.) and 4.4 (Other Maintenance Bldg.) in order to construct a new building to house several operational departments, and (4) acquire land to construct new preschool center on the northside of town.

Background/Rationale: These changes can be accomplished via the amendment process described in Section 502 of 702 KAR 4:180, The School Facilities Planning Manual. A quorum of the LPC convened on March 5, 2024, to consider these amended items and to vote on these changes per the amendment process as referenced above. The vote was unanimous, and these items were put together in a draft form and sent to KDE for review and comment. KDE responded stating that the draft DFP amended changes are acceptable contingent upon adjustments made as noted in the KDE comments.

A quorum of the LPC then met on May 30, 2024 and reviewed the comments. The LPC agreed with the KDE changes and then approved the amended plan (#3). Attached is a copy of the amended DFP with the KDE comments shown, but the changes have already made. Therefore, the staff supports the Board's approval of the recommendation from the Local Planning Committee (LPC) to amend (#3) to the current 2021 District Facility Plan (DFP) per the Amendment Process described in Section 502 of 702 KAR 4:180, The School Facilities Planning Manual.
