The Grande Corporate Membership Agreement

Thank you for your interest in becoming a partner with The Grande. We are honored that you have chosen to do business with us and offer your employees and staff the opportunity to better themselves through the use of our facility and services. Our staff is committed to providing the information and services you need to create a seamless business partnership.

As a part of this agreement, The Grande, LLC will offer full membership services to individuals employed by Simpson County Schools at a discounted rate of \$30 per person per month. Active Memberships will be covered according to the following schedule. Members will be responsible for \$10 paid directly to The Grande with the remainder (\$20) being invoiced directly to Simpson County Schools to cover the cost of each Corporate Membership. In addition, The Grande will also offer the discounted membership rate to family members of employees on an Individual Pay basis, not to be covered by Simpson County Schools.

The Grande requests that all employees of Simpson County Schools complete a Membership Authorization form, to also be signed by an authorized representative of Simpson County Schools as well as a member of The Grande's management staff. Once this paperwork has been completed, employees will be able to complete their membership option **in person** at The Grande. They will be required to complete all membership documents including contracts and liability waivers.

The Grande requests monthly verification of employment status to ensure the Corporate Membership Agreement is being utilized by current employees of Simpson County Schools. If requested, The Grande can also supply a list of participating employees in addition to monthly visits/check-ins.

We do not require any long-term contracts and this agreement can be terminated at any point by Simpson County Schools as long as proper notice is received.

The Grande Membership Authorization

This form authorizes The Grande to add the employee listed below to Simpson County Schools' Corporate Membership Plan. The discounted membership rate of \$30/month for employees of Simpson County Schools will be paid through a \$10 monthly deduction for the employee directly to The Grande with the remaining balance being covered by the employer. By signing this form, the employee understands that they are required to attend the gym at least eight (8) times per month and that their membership is covered only while employed by Simpson County Schools. The employee understands that they must still meet all membership requirements of The Grande, including membership contracts and liability waivers. If the employee's status with Simpson County Schools is terminated for any reason, the employee would be responsible for acquiring their own membership with The Grande to maintain membership privileges.

Employees are able to add on additional family members at the discounted rate of \$30 per person per month to be paid directly to The Grande on a Corporate "Individual Pay" membership option. Simpson County Schools is not responsible for covering any additional family add-on members.
