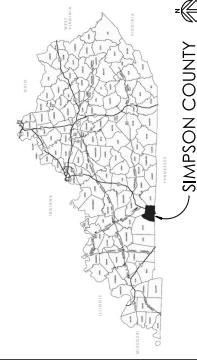

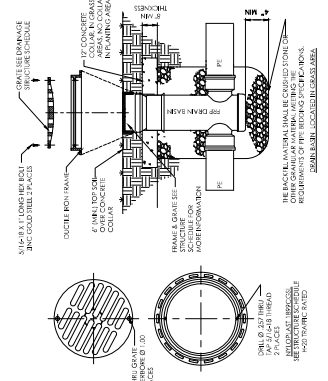


TRENCH DRAIN DETAIL
