**Recommendation/Motion:** Approve the revised BG-1 Project Application for the construction of the New Elementary School on Greendale Road in the amount of \$42,895,000.00 (Forty-two Million, Eight Hundred Ninety-five Thousand Dollars.)

**Background/Rationale:** The construction of the New Elementary School on Greendale Road is listed as priority 2.a.1. on FCPS's 2021 District Facility Plan (DFP). The Director of FCPS Facility Design & Construction has drafted a preliminary cost estimate for the new construction, yielding a final project of approximately 80,818 SF to serve 750 students (K-5). The program is consistent with other recent FCPS school projects and the KDE model program. Project cost estimates are based on the most recent construction bids and include: design and financing fees; furnishings; surveys; and other miscellaneous project costs. The revisions to the BG1 include the costs associated with the Construction Manager approved by the Board at its July 22, 2024 meeting, along with the cost for demolition of the existing house on the site.

Based on the rationale above, a revised BG-1 Project Application is required as follows:
