FCPS CTE Department agrees to:

- Collaborate in an annual planning session that establishes partnership goals and strategies.
- Annually assess and evaluate the partnership progress towards goals.
- Publicly recognize and promote the convenor partnership.

BCTC, the Convening Organization, agrees to:

- Maintain a partnership liaison position at all times focused on the designated roles of the Convening
 Organization outlined in this MOU, and alert FCPS or the Department of CTE when changes to this position
 occur.
- Collaborate in developing and leading quarterly partnership council meetings.
- Collaborate on an annual planning session to establish partnership goals and a strategic plan.
- Annually assess and evaluate the progress in obtaining partnership goals.
- Publicly recognize and promote the convenor partnership.

Financial Data and Terms

- The Convener Liaison's salary is \$75,190.03 + 43% benefit rate of \$32,331.71 for a total of \$107,521.74
- Both FCPS and BCTC agree to pay 50% of the salary, beginning July 1st, 2024
